PRIVACY & COOKIE POLICY

UPDATED October 2021

This Privacy Policy describes how your non-personal-identifying and personal information is collected, used, and shared when you visit or make a purchase from www.BuyLowWarehouse.com (the "Site").

PERSONAL INFORMATION WE COLLECT

When you visit the Site, like most website operators, we automatically collect certain non-personally-identifying information that web browsers and servers typically make available, such as your device, including information about your web browser, time zone, language preference, referring site, date and time of each visitor request and some of the cookies that are installed on your device. Additionally, as you browse the Site, we collect information about the individual web pages or products that you view, what websites or search terms referred you to the Site, and information about how you interact with the Site. We refer to this automatically-collected information as "Device Information". Site's purpose in collecting non-personally identifying information is to better understand how Site's visitors use its website. From time to time, Site may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Software also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on our blog. Software only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that blog commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog where the comment was left.

We collect Device Information using the following technologies:

- "Cookies" are data files that are placed on your device or computer and often include an anonymous unique identifier. For more information about cookies, and how to disable cookies, visit http://www.allaboutcookies.org.
- "Log files" track actions occurring on the Site, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps.
- "Web beacons", "tags", and "pixels" are electronic files used to record information about how you browse the Site.

Certain visitors to Site's Website choose to interact with Site in ways that require Site to gather personally-identifying information. The amount and type of information that Site gathers depends on the nature of the interaction. Those whom engage in a purchase or attempt to make a purchase through Site are asked to provide certain additional personal and financial information, including your name, billing address, shipping address, payment information (including credit card numbers and any other billing information from other forms of payment accepted), email address, and phone number. We refer to this information as "Order Information". In each case, Site collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Site. Site does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

When we talk about "Personal Information" in this Privacy Policy, we are talking both about Device Information and Order Information.

HOW DO WE USE YOUR PERSONAL INFORMATION?

We use the Order Information that we collect generally to fulfill any orders placed through the Site (including processing your payment information, arranging for shipping, and providing you with invoices and/or order confirmations).

Additionally, we use this Order Information to:

- Communicate with you;
- Screen our orders for potential risk or fraud; and
- When in line with the preferences you have shared with us, provide you with information or advertising relating to our products or services.

We use the Device Information that we collect to help us screen for potential risk and fraud (in particular, your IP address), and more generally to improve and optimize our Site (for example, by generating analytics about how our customers browse and interact with the Site, and to assess the success of our marketing and advertising campaigns). Site may display this behavior and interaction information publicly or provide it to others. However, Site does not disclose personally-identifying information other than as described below.

Additionally, we use the Device Information to facilitate online & offline targeted advertising campaigns such as retargeting, abandoned cart targeting, email marketing, and social media marketing campaigns.

SHARING YOUR PERSONAL INFORMATION

We share your Personal Information with third parties to help us use your Personal Information, as described above.

Site discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Site's behalf or to provide services available at Site's website, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of

your home country; by using Site's websites, you consent to the transfer of such information to them. Site will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Site discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when Site believes in good faith that disclosure is reasonably necessary to protect the property or rights of Site, third parties or the public at large. If you are a registered user of a Site's website and have supplied your email address, Site may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Site and our products. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Site takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

BEHAVIOURAL ADVERTISING

As described above, we use your Personal Information to provide you with targeted advertisements or marketing communications we believe may be of interest to you.

COOKIES

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Site uses cookies to help Site identify and track visitors, their usage of Site's website, and their website access preferences. Site's visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Site's

Additionally, please note that your information will be transferred outside of Europe, including to Canada and the United States.

BUSINESS TRANSFERS

If Site, or substantially all of its assets, were acquired, or in the unlikely event that Site goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may
